

Article I: Name

The name of this association is the Gideons Elementary School PTA _____

Parents and Teacher Association, Atlanta _____ City _____, Georgia.

Article V: Membership and Dues

Section 7

Each member of this local PTA\PTSA shall pay annual dues of \$5 to said association. *(For example, if membership dues are \$6.00 per member; \$2.25 is national portion, \$1.50 is state portion, and \$2.25 remains with the local unit)*

Article VI: Officers and Their Election

Section 1:

The officers of this PTA\PTSA shall consist of one (1) president or two (2) individual co-presidents, 1 vice-president(s)*, 1 secretary(ies) and a treasurer. *(Georgia PTA does not approve co-treasurers or co-vice presidents. *Designate officer responsibilities and titles, if applicable such as 1st Vice President – family engagement, 2nd Vice President - student services)*

Section 3:

Officers shall be elected in the month of ** April **. *(Recommended: April - **must be the same as Article V, Section 7c and Article XIII, Section 3**)*

Section 6:

Officers shall assume their official duties following the close of the school year serve for a term of 1 year(s) or until their successor is elected. *(Recommended: one year)*

Section 8:

There shall be a nominating committee composed of 3 members (must be an uneven number) and 1 alternate(s) who shall be elected by this local PTA\PTSA at a regular general membership meeting at least one month prior to the election of officers, as outlined in Article VI, Section. *(Recommended: 3 members with 1 alternate)*

Section 8 c:

The nominating committee shall nominate an eligible person for each office to be filled and report its nominees at the regular general membership meeting in ** April ** at which time additional nominations may be made from the floor. *(Recommended: April **must be the same as the above Article V, Section 2 and Article XIII, Section 3**)*

Article XII: Standing and Special Committees

Section 3:

The term of office of a committee chair shall be 1 year(s) or until the selection of a successor. *(Recommended: one year)*

Article XIII: General Membership Meetings

Section 3:

The election meeting shall be held in ** April ** (Recommended: April **must be the same as Article VI, Section 3 and Section 8c**))

Section 6:

11 members shall constitute a quorum for the transaction of business in any meeting of this local PTA/PTSA. (Recommended: 15)

Article XIV: Council Membership

Section 1:

This local PTA/PTSA shall be represented in the meetings of the Atlanta Council PTA by the president or their alternate, the principal, or their alternate, and by two (2) delegates or their alternates. (Name of the Council your unit falls within)

Article XVI: Fiscal Year & IRS Form 990

Section 1:

The fiscal year of this PTA\PTSA shall begin on July 1 and end on the following June 30 (Recommended: June 1 / May 31)
